The age of the dog on the day of the show is decisive for inclusion in the class, other conditions must be met on the day of application. **The application must be accompanied by a current complete copy of the pedigree of the entered dog and a copy of the proof of payment of the show fee.**

**\* a copy of the test certificate must be attached to the application or a photocopy of the proof of award. Without these attachments, the dog will be placed in the open class. As CMKU exhibition rules say.**

**Titles:** CAJC, CAC, res. CAC, CCJ, CC, CCV (waiting for club champion), CC WUT, Best Junior (BOJ), Best Veteran (BOV), Breed Winner (BOB), Best of Opposite Sex (BOS), Best working dachshund, Best veteran, Best individual in honor classes, Best puppy of show, Best puppy male and female, Best young individual, Winner of show

**Competitions:** The Best Brace - for male and female of the same breed and variety judged at this show owned by one owner

The best breeding group - for at least 3 individuals and a maximum of 5 individuals of the same breed and variety judged at this show coming from the same kennel from at least two different fathers or mothers. The breeder does not have to be the owner of the individuals.

The best progeny - a parent with at least 5 offspring who were judged at the show enters this competition. The type and quality of breeding are evaluated. The parent of the breed does not have to be judged at the show in normal competition.

It is possible to register for these competitions on the spot on the day of the exhibition. The exhibition office will be open all day for this purpose. Without a fully completed application, the couple or group will not be accepted into the competition. Other competitions result from the exhibition award according to the exhibition catalog.

**KCHJ ČR reserves the right to change judges, or redistribution according to applications after the deadline.**

**Veterinary regulations:** Dogs must be equipped with a passport for small animals or a vaccination card (according to § 6 paragraph 3 letter b of Act 166/1999 Coll., As amended by the Veterinary Act). All animals must have a valid vaccination against rabies, canine distemper and parvovirus. Dogs from breeders from EU member states and third countries must meet the conditions set out in Regulation 998/2003 of the European Parliament and of the Council of 26 May 2003.

**Protests:** protest against the judge's decision is not admissible, protest for formal reasons (violation of show regulations or propositions) is admissible. It must be submitted in writing during the show together with the deposit of twice the show fee for the first dog (CZK 1120.00). I discuss them by a committee consisting of the main judge, the director of the show, one of the judges and with the participation of the person who submitted the protest. If the protest is not recognized by the commission as justified, the deposit will be forfeited in favor of the organizer.

#### General provisions:

- Received applications will be confirmed in writing no later than one week before the exhibition.
- If the exhibition does not take place for unforeseeable reasons, the fees will be used to cover the costs associated with its organization.
- The show is open to all dachshunds registered in the FCI studbooks who have reached the age of at least 4 months on the day of the show. Imported individuals must be registered in the CMKJ studbook.
- The exhibitor is responsible for all damages caused by his dog.
- The organizer is not responsible for damages that may result from the death or loss of the dog.
- Excluded from participation in the show are dogs owned by persons who have been banned from the show, bitches in the second half of pregnancy, lactating bitches and puppies up to 4 months of age. Furthermore, sick, blind dogs and individuals with an obvious veterinary intervention, which should have removed the exterior defect, dogs owned by the judge or his wife (husband), if this judge is judging at the show.
- Changes to the dog's exterior made by varnishing, powdering, coat toning and basic trimming with mooring dogs on tables are prohibited.
- The sale of dogs and puppies at the show is prohibited!

**Refreshments and accommodation can be provided directly on the exhibition grounds.  
Exhibition is outside.**

**Possibility of a banquet on Saturday evening for 25 EUR, apply and pay with the application.**
